**FULBRIGHT BULLION LIMITED (the "Company")**  
**PERSONAL INFORMATION COLLECTION STATEMENT**  
**富昌金業有限公司 ( "本公司" )**  
**個人資料收集聲明**

This Statement is issued by Fulbright Bullion Limited (hereinafter referred to as the "**Company**") and its subsidiaries, affiliates and related companies (hereinafter referred to as the "**Group**") and sets out the Company's policies in relation to the collection and use of the Client's personal data.

本聲明由富昌金業有限公司 (以下簡稱「**本公司**」)及其附屬公司、聯屬及關連公司(以下簡稱「**本集團**」)發出，並列明其向客戶收集個人資料之政策、實際應用及收集資料所作之用途。

**1. Provision of Personal Data**  
**提供個人資料**

It is voluntarily for the Client to supply the personal data as required by the Company. If the Client fails to supply the required personal data, the Company may refuse to open or maintain the Client's account or may refuse to provide services to the Client.

客戶應自願提供本公司所需的個人資料。如客戶未能提供所需個人資料，則本公司可拒絕為客戶開設或持續操作帳戶或提供相關的服務。

**2. Purposes and Uses of Data Collection**  
**收集資料的目的及用途**

The personal data provided by the Client to the Company and in any documentation which comes into existence as a result of the Client's opening or maintaining of account with the Company, will be used for the following purposes:

客戶因在本公司開設或持續操作帳戶而向本公司提供的個人資料，或任何文件列載的個人資料將被用作以下用途：

- a) opening, management and continuous operation of the Client's account;

- b) buying, selling, investing, conducting transactions, providing custody, handling and processing of precious metals trading on behalf of the Client;

- c) ensuring the Client's ongoing credit worthiness;  
確保客戶的信譽維持良好；
- d) designing financial services or related products for Client;  
為客戶設計金融服務或相關產品；
- e) collecting of amounts outstanding from Client or any guarantors;  
向客戶及對客戶之對客戶擔保人士追收欠款；
- f) enforcing disclosure of information requirements in compliance with application laws, regulations or rules;  
根據集團任何成員須遵守之法例、法規或規則作出披露；
- g) maintaining Client's credit history for present or future reference;  
維持客戶的信貸紀錄供現時或將來參考之用；
- h) direct marketing and/or cross-selling of the financial and investment products and services provided by the Company and/or any of companies in the Group as stated under Paragraph 3 hereinbelow; and/or  
在以下第 3 段所述之直接促銷及／或交叉銷售本公司及／或其他任何本集團的聯繫公司的財務、投資產品及服務及／或
- i) any other additional and related purposes.

### 3. Use of Data in Direct Marketing

#### 在直接促銷中使用資料

The Company intends to use the Client's data in direct marketing and the Company requires the Client's consent (which includes an indication of no objection) for that purpose. In this connection, please note that:

本公司擬把客人的資料用於直接促銷，而本公司為該用途須獲得客人同意（包括表示不反對）。就此，請注意：

- (i) the name, contact details, financial background and demographic data of the Client held by the Company from time to time may be used by the Company in direct marketing;

- (iv) in addition to marketing the above services, products and subjects itself, the Company also intends to provide the data described in paragraph (i) above to all or any of the persons described in paragraph (iii) above for use by them in marketing those services, products and subjects, and the Company requires the client's written consent (which includes an indication of no objection) for that purpose.

The Client's request shall apply to all personal account(s) maintained by the Client at the Company.

### 4. Privacy

#### 資料保密

Data held by the Company relating to the Client will be kept confidential but the Company and data collection parties may provide such information to:

- a) any agent, contractor and third party service provider who provides services to the Company in connection with the operation of its business;

- b) any other person under a duty of confidentiality to the Company who have undertaken to keep such information confidential;  
對本公司有保密責任且已承諾將個人資料保密的人士；
- c) any financial institution (whether in Hong Kong or elsewhere) with which the Client has or proposes to have dealings;  
客戶與之進行或擬與之進行交易的任何金融機構（不論是否在香港）；
- d) any legal, accounting or professional person, corporation or group;  
任何法律、會計或專業人士、公司或團體；
- e) any governmental, law enforcement or other regulatory institutions, bodies or entities in any jurisdictions; and  
在任何司法管轄區的政府、執法或其他規管機構、團體或實體；及

- f) any actual or proposed assignee of any member of the Group, participant or sub-participant or transferee of Client.

## 5. Transfer of Personal Data to Places outside of Hong Kong 將資料轉移到外地

The Company may from time to time transfer Client's personal data to places outside of Hong Kong for processing and storage subject to different purposes.

## 6. Client's Rights 客戶的權利

Under the Personal Data (Privacy) Ordinance (Chapter 486, Laws of Hong Kong), any person whose personal data is held by the Company has the right to:

- a) examine whether the Company holds personal data and the right of access to such data;

- b) request the Company to correct any data relating to him that is inaccurate;

- c) ascertain the Company's policies and practices with regard to personal data and be informed of kinds of personal data held by the Company; and  
查悉本公司對於資料的政策及實務及獲告知本公司持於其個人資料的種類；及
- d) opt out his/her personal data to be used for direct marketing at any time by giving notice and without charge to the Company and such notice shall take effect upon the expiry of 3 business days from the date of the Company's actual receipt for such notice.

The Company is entitled to charge reasonable fees for the processing of any personal data access request (save for the opt-out for direct marketing).
